If you believe an error may have been made in your billing, contact the office as soon as possible. You can also register for the 2024 Court of Revision which will be held on Saturday February 10<sup>th</sup> at the Van Anda Firehall.

### **Water Quality**

Our water continues to be of excellent quality, thanks to the water treatment plant installed in 2020. The system filters, removes sediments and organics, and disinfects our water using both ultraviolet light and chlorine. Our water routinely exceeds Vancouver Coastal Health requirements and there were no water quality warnings or boil water advisories this year.

#### **Leaks Status**

Leaks in VAID's water mains are continually being discovered and repaired, and leak detection is ongoing, including waterlines on private property.

### **Growth & Development**

Real estate movement has slowed down, as has land development. Note that developers pay for any system upgrades needed to provide water to their developments. Upgrades that may be needed for development include increased water treatment plant capacity, larger water mains, and possibly other distribution components. Engineering reports that the board deem necessary to determine if current water users will be impacted are also at the developers cost.

## **Climate Change & Water Restrictions**

As last 3 summers brought extended dry periods, we are seeing lower lake levels than previously recorded. Last summer we installed the intake pump on a float to ensure that low water levels at the intake well did not impact pump operation. Our water supply, Priest Lake, has plenty of water however we need to deepen the water intake well to adapt to lower water levels. Well maintenance performed this year showed cracks in the well casing and we are still determining the best way to proceed.

Seasonal water restrictions are put in place to manage the volume of water that is treated, as high usage can max out the plant capacity and water supply for fire protection. Please ensure your hoses have attachments to restrict full flow and let us know of concerns about excessive water use. Insulate pipes to avoid freezing: if you absolutely have to run water a trickle is all that's needed.

# **Encouraging Water Conservation**

We have noticed that the increased water usage in summer decreases noticeably for a couple of days after it rains. VAID will be starting a new program to ease up the summer load on the Water Treatment Plant. Drip irrigation is a method of plant watering that uses much less water than traditional methods. VAID will help you reduce the costs of purchasing a drip irrigation system – please contact us for details.

### **Employee Changes**

We have 2 new employees who started working for VAID in 2023. Joseph Scott (Administrative Assistant) and Marianne Segers (Water Operator) are excellent additions to the team. Austin Rycroft continues as Water Operator and Sandra Haszard as Administrator.

#### **Tolls & Taxes**

We managed to keep this year's increase of Water Tolls and Parcel Taxes down to 6 %, which is quite reasonable, and a lower increase compared to many jurisdictions, especially given the inflationary pressures that hit us this year. Payment plans are available; see your invoice for details.

Interested in keeping your community safe?

A couple of hours a week are all you need to become a volunteer firefighter:

- No previous experience necessary.
- All required personal protective equipment and training are provided at no cost.
- Only have to fill out an application form and criminal record check.
- On duty insurance coverage.
- Practice once a week for two hours with occasional weekend training.
- Tax credits from the federal government are provided to volunteer firefighters who serve at least 200 hours per year.

The Fire Act changes mean that all members don't need to be trained in everything. There is room on the team for people who just want to drive the truck, run the pump, or do any other activity.

Anyone interested in joining is welcome to attend a practice. These are held on Monday nights beginning at 6:30 pm. (This may be changed to weekends to accommodate shift workers.) You don't have to live in the Van Anda District to join.

#### Training

Hall training focuses on practical skills, hazard awareness, SCBA (Self Contained Breathing Apparatus) training, ropes and pulleys, pumper skills, hydrant hookup with truck pressurization, traffic control, and radio use. First Responder medical scenario training is ongoing, as is forestry training.

VAFD and Gillies Bay Fire Department train together often and work well together at incidents. Training with GBFD this year included: BCAS ambulance familiarisation; naloxone use; forestry structure protection; road traffic safety; structural protection practice/training; MVA incidents; fire tactics; hydro.

Volunteer Firefighters training and expenses will be covered by the Fire Department for training away, including items such as Live-Fire, EMA accreditation, Critical Incident Stress Management, Air Brakes endorsement, and Class 4 endorsement on Driver's License.

#### **Equipment Upgrades**

VAVFD has purchased 3 sets of safety boots, 4 wildland helmets, 2 SCBAs with 4 tanks, one hydrant, 2 climbing harnesses, 1200 USG portable water tank, hoses, pager, radio, 2 trauma bags, hydrant flow test

kit. The bay doors were replaced with powered doors that can be opened and closed with a remote. The old doors were heavy, unsafe, and had been repaired multiple times. The new doors seal properly and are saving on hydro costs.

### **Grant Received**

In October, we successfully applied for a \$ 24,644 grant through UBCM for Community Emergency Preparedness Funds for Volunteer and Composite Fire Departments. The funds are to be used for training and the following equipment: turn out gear; wildland firefighting PPE; 1200 USG portable water tank; mark-3 water pump, suction hose, foot valve, fuel line and fuel can; incident command Wildland PPE; shovels, pick-head fire axe, and other fire tools; First Aid kit and case; and more.

#### **Increased Fire Protection Area**

Property owners in Crescent Bay and the surrounding area have expressed interest in obtaining Fire Protection from VAVFD. This can be done by amending the ID boundaries. If boundaries are amended, these new properties will share in the Fire Protection Tax that is collected as part of the Rural Property Tax. Owners have been providing Applications for Boundary Amendment so that we can move forward with this change.

# **Merging Fire Departments**

Van Anda and Gillies Bay Fire Departments are again discussing the possibility of merging. The 2 FDs already work well together as well as sharing training and resources. If we can find a suitable method to merge, one major benefit would be that only one new Fire Truck (each costing over a million dollars) needs to be purchased every 25 years, instead of the 2 required while the Departments are separate. Thus, merging the Fire Departments would decrease the tax burden to Texada Island residents while maintaining the same level of protection from fire. The possibility of a merge was explored about 10 years ago and was ultimately decided against, but many things have changed since then. There may be alternatives to those presented previously. Investigations are ongoing, with the assistance of Provincial authorities such as Municipal Government and the Fire Commissioners Office.
