VAID Water System Report for 2024

ANNUAL GENERAL MEETING April 26, 2025



Water Quality

A Water Quality Advisory was in effect for most of the year and there were several short-term Boil Water Notices. 2024 brought many challenges with our five-year-old water treatment plant, most of which have been resolved, and plans are in place for the rest.

The Water Quality Advisory was due to temporary Ultraviolet Treatment (UVT) insufficiency. UVT is the final step in water treatment before chlorination. The UVT system was not adequate due to the dissolved solids not being removed by the Ion Exchangers (Ionex), as designed. Replacement of the Ionex media solved this issue. This job was contracted to Aaron Service & Supply and was completed Feb 2025.

Replacement of the chlorine analyser and related devices is planned – we expected it to have been completed by the AGM though this is delayed due to shipping error. This aged equipment caused fluctuations in amount of chlorine added to the water. This will solve the issue that caused two of the Boil Water Notices.

Another issue we had with chlorination was weakened strength of undiluted chlorine received from the supplier. Procedures were put in place to prevent this happening again, such as testing each shipment received and a change of the source. We also added ventilation to our storage container to prevent the possibility of heat damage in summer.

The addition of a sand filtration unit between the self-cleaning filters and the cartridge filters is expected to commence late 2025. This sand filter was donated to VAID from a Vancouver Island location that has since connected to a larger water supply system. It will save us money on treatment consumables such as cartridges, chlorine, salt, and electricity, and extend the life of the new ionex media. Also planned is a new chlorination system, rebuild of Wall St pumphouse, new floating dock in lake, and continued leak detection on private property.

Tolls & Taxes


We kept 2025 increase of Water Tolls and Parcel Taxes for most properties to 6%, which was the minimum required, especially given the inflationary pressures that continued this year. Parcel taxes have always been higher for owners of larger properties; we are gradually closing the gap by keeping the rate increase lower on larger parcels while preparing Revenue Budgets. As we've heard concerns about the fairness of water tolls, VAID will be holding a community engagement session in the next month or two regarding how water tolls can be equitably set.

Leaks Status

Leaks continued to increase in 2024 even after the many repairs during the year. We thank every one that reported leaks

The volume of water treated for 2024 was 172,307 cubic meters compared to 110,187 for 2023 — an increase of 64%. We were concerned that the water treatment plant will not be able to keep up with increased summer use so finding these leaks continued to be our major priority. Due to the severity of this situation, a leak detection specialist was contracted - Velocity Water Services were here in January 2025 using their industry-leading technologies in acoustic leak detection to locate water leaks. The report can be found online at vananda-id.ca/reports/

Repairs during February and March at the locations identified reduced water consumption by more than half! Average daily amount for November (before any freezing weather) was 518 cubic meters per day, or 137,000 US Gallons. Some days were close to the maximum plant production of 610 cubic meters (160,000 USG). For March (after the repairs), the average daily amount was 242 cubic meters (63,850 USG). Per capita use has dropped from 1,141 (Jan & Feb) to 505 litres per person per day (Mar 13 – Apr 2).



Water processing costs us money - electricity, cartridge filters, filter media, water softener, chlorine, maintenance parts, and labour - and repairing leaks will save money spent on water treatment. The treatment cost savings from these repairs quickly covers the cost of the specialist and the repairs.

Detecting Leaks on Private Property

Even with the recent large drop in water use, the per person usage is still double the Canadian average. We have made significant progress with leak repair on watermains however we have already found several leaks on private property and suspect there are many more.

To perform the test, VAIDs water operators will contact you before they begin. They will use a water pressure gauge at your hose bib or where the waterline enters the house. We ask that you shut off any water using appliances or devices during the test. If a leak is detected, property owners are responsible for repair of water leaks on their property. Our water operators will provide you with information on standards for repairs.

Climate Change & Water Restrictions

Recent summers brought extended dry periods, with lower lake levels. The intake pump is now on a float to ensure that low water levels at the intake well do not impact pump operation.

Our water supply, Priest Lake, has plenty of water. Seasonal water restrictions are put in place to manage the volume of water that is treated, as high usage can max out the plant capacity and decrease water supply for fire protection. We heard your comments and suggestions, and the Water Conservation Bylaw was changed this year to be clearer about Restrictions.

Restriction details with dates, times, and type of water use can be seen at vananda-id.ca/water-restrictions/
Please ensure your hoses have attachments to restrict full flow and let us know of concerns about excessive water use. Insulate pipes to avoid freezing. Once again, we had several leaks manifest after freezing conditions warmed up. Searching for these leaks used many hours of water operator labor.

To encourage water conservation, we are continuing with our program of offering a discount for drip irrigation parts. This is a method of plant watering that uses much less water than traditional methods. VAID will help you reduce the costs of purchasing a drip irrigation system — please contact us for details.

Mining Concerns

VAID has written a response to Zyrox's application. It will be placed on the VAID website and on VAID's Facebook page.

New Water Connections

3 new connections were completed on Wall St, 2 for the subdivision in progress and one for another property that became part of the District at the same time. With the possibility of 3 more connections in the subdivision; the developer has agreed to pay for the Wall St pumphouse upgrades that are needed to support the extra connections. Another development in progress that water supply has been agreed to is a Bare Land Strata with 12 metered connections and includes a new hydrant. Other potential developments in Van Anda have not yet reached the stage of applying for water.

Employee Changes

We have a new employee who started working for VAID in 2024 after Austin Rycroft resigned. Trevor Morrison (Water Operator) started in April 2024. Marianne Segers continues as Water Operator and Sandra Haszard as Administrator. Joseph Scott's position has changed to Operations Coordinator. Joining us this year is Bernardo Reyes, experienced in many aspects of Water Operations and working as a contract employee. All employees work part time.

Employee Training Completed

The Water Operators and Operations Coordinator completed several EOCP accredited on-line courses from BCSWS, Dragonetti Group, and Interior Health on a variety of topics.

VAID Work Vehicle

VAID has purchased a pickup truck for water operator use. Thanks to the generosity of community members, a good part of the purchase cost was covered. Analysis of expenses show that expenditure will be less than the mileage amount currently being paid to employees. Additionally, regularly used tools, fittings, and supplies can be stocked in the truck for improved work efficiency.

Text Notification System

We have set up a system for notification by text. If you know of anyone who would like to be texted when there are water issues, please let us know.

Training

In 2024, members completed training for Emergency Medical Responder First Aid, S-100 Wildfire (BC Wildfire Service recognized Basic Fire Suppression and Safety), Live Fire exterior and interior firefighting at the facility in Lund, and a chain saw operator's course.

Training so far in 2025 includes Vehicle Extrication; planned is Jaws of Life training – one day will be with GBFD and another day with Lafarge Mine Rescue.

VAFD and Gillies Bay Fire Department train together often and work well together at incidents. Training with GBFD this year included live fire training on Texada – 2 boats and 2 structures.

Equipment Upgrades

In 2024, we purchased a fire suppression blanket for vehicle fires. Some electric vehicles may take up to four hours to put out with just water. With the blanket and water, it can be put out much faster by cutting oxygen out of the fire triangle. Other upgrades include a new first aid kit, a new O2 tank, SCBA facemasks, ladder, toolbox, tools and supplies for fire and rescue vehicles, and forest firefighting equipment. Electrical work was completed at the Firehall to repair heaters and wiring.

For 2025, purchases include 6 SCBA tanks, 8 new hoses for the firetrucks, first aid kit, gate for below Legion (replacing blocks in road so emergency access is possible), 602 brake repairs, hats and toques for members, and 3 sets of turn out gear. VAFD shared the repair cost with GB for the air compressor located in Gillies Bay Firehall. Ordered and expected soon are hydrant de-chlorination diffuser (removes chlorine from water during flushing) and 2 climbing harnesses for rescue.

New Rescue Truck

In March 2025, we purchased a 2011 Dodge Ram 2500 from Qualicum Beach Fire Department. This vehicle is in excellent condition and has been well maintained. Being a crew cab, there is room for more responders. Medical calls outside the ID boundaries are responded to in the Rescue vehicle. The old truck seats only 2 responders; on some calls we had 3 members driving their personal vehicles to calls. Without lights and sirens, they do not have right-of-way to these calls. The old rescue truck will be used along with the new one for medical calls and wildfire response.

Community Emergency Preparedness Grant

The 2023 grant funds were received in 2024 (\$24,644). These were used for S-100 forest fire fighting training, turnout gear, a 1200 USG portable water tank with carry case and ground tarp, Mark-3 pump package (including suction hose, foot valve, fuel line, and fuel can), protective jackets and vests, forestry shovels and axes, and other forestry gear.

Wildfire Skid Donation

The Texada Fire Fighters Association received a donation of a wildfire skid. This is a self-contained 1200L tank, a wildfire pump, and a section of hose on a skid that fits in the back of a pickup or on a trailer. The donor, GlobalMedic, was donating a number of these units across Western Canada, and we were lucky enough to get one.

Merging Fire Departments

Van Anda and Gillies Bay Fire Departments looked more at merging, but it seems there is no way to do this while keeping full control of the FDs on Texada. Along with training together, both are now part of Texada's Fire Fighters Association.

Texada Island Volunteer Firefighters Association

Both department's members now belong to an Island wide group, Texada Volunteer Firefighters Association. Any activities undertaken for the Fire Department by Volunteer Firefighters Associations will now be with the Texada group.

Increased Fire Protection Area

20 property owners outside the Van Anda Improvement District (ID) applied to become part of the ID. Of these, 6 now have agreements for Temporary Fire Protection until the District Boundary change is complete. Both Texada's Fire Departments (FDs) will respond to a fire on these properties. 6 other owners decided not to proceed after being informed of the estimated increase to their Rural Property Tax for funding the FD. There was no response from the remaining owners to continue with their applications.

The FDs of Van Anda and Gillies Bay have an agreement in place for immediate response to fires in both IDs. Fires within the boundaries of either ID are attended to by both FDs without delay. Our FDs cannot attend fires outside the IDs, unless called in by Forestry. Forestry will not act on structure fires or request FD assistance until the fire has spread to the forest. This means valuable time is wasted, which could lead to a disastrous situation.

Annual Burn Ban

We heard your comments and suggestions, and the Fire Regulation Bylaw was changed this year to be clearer about burning restrictions and match up with those in Gillies Bay. The new bylaw can be found on our website vananda-id.ca/fire-restrictions/ along with BC Wildfire Service Fire Danger Rating and Coastal Fire Bans.

General Information

Mark Robert accepted the position of Fire Chief. Mark was Acting Fire Chief since Mike Craggs left. Firefighters have insurance coverage in case of accident. This was previously limited to Fire Department activities only. In 2024, we extended the coverage to 24/7.

The Fire Department and Firefighters continue to assist BC Ambulance Service (BCAS) with patient movements and transport.

Please think about becoming a volunteer member and helping your community!

A couple of hours a week are all you need to become a volunteer firefighter:

- ✓ No previous experience necessary.
- ✓ All gear and training provided at no cost.
- ✓ Accident insurance coverage (new 24/7 coverage, not just while performing fire fighter duties).
- ✓ Practice once a week for two hours with occasional weekend training.
- CRA tax benefit.
- ✓ Having more firefighters helps lower home insurance costs for everyone in Van Anda.

Anyone interested in joining is welcome to attend a practice. These are held on Monday nights beginning at 6:30 pm. (This may be changed to weekends to accommodate shift workers.) You don't have to live in Van Anda to join.

Hall training focuses on practical skills, hazard awareness, SCBA (Self Contained Breathing Apparatus), ropes and pulleys, pumper skills, hydrant hookup with truck pressurization, traffic control, and radio use. First Responder medical scenario training is ongoing, as is forest fire fighting training.

Training away such as Live-Fire, EMA accreditation, Critical Incident Stress Management, Air Brakes endorsement, and Class 4 endorsement on Driver's License is paid for by the Fire Department and costs such as travel, food, and hotel are also covered.
